



THE CORPORATION OF THE TOWNSHIP OF AUGUSTA

BY-LAW NUMBER 2682

A BY-LAW TO AUTHORIZE THE ACCEPTANCE OF CERTAIN DEEDS OF LAND AND TO ASSUME AND DEDICATE THE SAID LANDS FOR ROAD PURPOSES

WHEREAS the Municipal Act 2001, SO 2001, Chapter 25, Section 8 gives the municipality the capacity, rights, powers and privileges of a natural person for the purpose of exercising its authority under this act;

AND WHEREAS the Municipal Act 2001, SO 2001, Chapter 25, Section 9(1)(a, b) states that Sections 8 and 11 shall be interpreted broadly so as to confer broad authority on municipalities to govern their affairs as they consider appropriate and to enhance their ability to respond to municipal issues;

AND WHEREAS the Municipal Act 2001, SO 2001, Chapter 25, Section 9(2) states that in the event of ambiguity in Sections 8 and 11, those sections shall be interpreted broadly to include, rather than exclude, municipal powers that existed on December 31, 2002;

AND WHEREAS numerous parcels of land have been deeded to the Corporation of the Township of Augusta for road widening purposes as a condition of the granting of a severance by the Leeds and Grenville Land Division Committee.

AND WHEREAS it is deemed expedient to accept these said parcels of land to assume and dedicate them for road purposes.

NOW THEREFORE THE COUNCIL OF THE TOWNSHIP OF AUGUSTA ENACTS AS FOLLOWS:

1. That the lands listed and described in the attached Schedule "A" of this by-law are accepted by the Corporation of the Township of Augusta.
2. That the said lands be and they are hereby assumed by the Corporation of the Township of Augusta.
3. That the said lands be and they are hereby dedicated as part of the Township of Augusta for the road on which they are situated as listed in the herein attached aforementioned Schedule "A".
